## TUCSS PROJECT OF THE YEAR AWARD 2024

Tunnelling and Underground Construction Society Singapore (**TUCSS**) is pleased to announce the third edition of TUCSS PROJECT OF THE YEAR Award 2024 (**the Award**). The winner of the award will be announced at the TUCSS Annual Dinner.

TUCSS Project of the Year Award is an initiative by TUCSS to enhance the professional standards of tunnelling and underground construction works in Singapore and acts as a stimulus for the growing pool of tunnelling and underground construction engineers in Singapore to raise the bar in professional standards, knowledge, best practices and broaden the mind set of innovation to achieve excellence in such works.

The Award provides a platform to showcase the epitome of well-executed tunnelling and underground construction projects from planning, logistic, risk management, cost effectiveness, safety standards to the successful delivery of the project to clients and accords recognition to the winning project team each year for outstanding efforts, contributions and achievements in tunnelling and underground works in Singapore.

Nominations for the TUCSS PROJECT OF THE YEAR Award are invited from the **corporate members** of TUCSS.

### ELIGIBILITY

To be eligible for participation, the nominated project must satisfy the following criteria:-

- (a) project budget must be greater than Singapore Dollars Thirty Million (SGD\$30million).
- (b) project must be recently carried out and completed in Singapore.
- (c) project team must display management expertise in carrying out the works safely and promptly;
- (d) project must adopt innovative approaches or ideas, which contribute to increased productivity and advancement of the local profession or the industry.

(collectively, **the Eligibility Criteria**)

## SUBMISSION

Each nomination for the Award (**Nomination**) must be submitted using the prescribed Nomination Form attached in **Annex A**. The Nomination Form may also be downloaded from TUCSS website at: <http://www.tucss.com.sg>.

The submission of each Nomination (**Submission**) must be accompanied by an Executive Summary on the nominated project, of **not** more than one thousand (1000) words, that addresses the Eligibility Criteria, state the project details including complexity and challenges faced and how they have been overcome as well as the contributions and achievements together with all relevant supporting documentations and data.

TUCSS reserves the right to disqualify any Nomination which in its assessment does not meet the Eligibility Criteria. No notification or reasons will be provided to the disqualified Nominations. All decisions by TUCSS with respect to the qualification or disqualification of any Nomination shall be final and binding. There shall be no claims whatsoever against TUCSS arising from such decision.

The duly completed Nomination Form for the Awards, together with the Executive Summary and all the supporting documents and data, must be received by the TUCSS Secretariat **NO LATER THAN 1 August 2024** at the following address:

## JUDGING PANEL

An independent Judging Panel comprising three (3) prominent experts will be appointed by the TUCSS President to evaluate the shortlisted Nominations and decide on the winner of the Award.

## PRESENTATION TO JUDGING PANEL

Only shortlisted nominees will be notified in writing and will be required to conduct a twenty (20) minutes presentation before the Judging Panel during the period between August to September 2024.

Unless otherwise notified in writing by TUCSS, the presentation must be in the form of a PowerPoint, multi-media and / or video presentation.

Such presentations **MUST** amongst others demonstrate how challenges encountered by the relevant project were overcome, how safe and prompt completion of the works was achieved notwithstanding such challenges and display any innovative approaches or ideas adopted.

Site visits may also be required by the Judging Panel to view the projects and if required, shall be arranged by the shortlisted nominees.

All presentation materials shall form part of the Materials (as defined below) for the Submission for the relevant shortlisted Nomination.

## RIGHT OF USE OF CONTENTS OF SUBMISSION

Without prejudice and in addition to any rights of TUCSS reserved in this document and any rights TUCSS have with respect to personal data under its privacy policy, TUCSS shall have the right to use any information including any documents, materials and data provided to TUCSS in connection with each Nomination (collectively, **Materials**):-

- a. for purposes of the Award, including:-
  - (i) processing, monitoring, evaluating and reviewing the Nomination;
  - (ii) maintenance and review of the Award;

The results of the Award will be announced and awarded at the TUCSS Annual Dinner and will thereafter be published on the TUCSS website at: <http://www.tucss.com.sg>. The winner of the Award will receive a specially designed trophy and a Certificate of Achievement.

## CONDITIONS OF AWARD

Each Submission shall be subject to all terms and conditions (for which TUCSS reserves the rights to change from time to time and at any time and notify such changes, if any, on its website), representations and warranties contained in this document including the following, (collectively, **Conditions of Award**). Corporate member(s) submitting a Nomination shall be deemed to have accepted these Conditions of Award and shall procure and shall be deemed to have procured the nominee's agreement to the Submission and these Conditions of Award including the following:-

- a. the nominee shall have read, understood and agreed to be bound by all the Conditions of Award set out in this document for its nomination for the Award. On submission of the Nomination, the nominee is deemed to have given TUCSS a perpetual irrevocable non-exclusive royalty free right to use any Materials for the Purposes without infringing any copyright or other intellectual property of any third party.
- b. the nominee agrees to be fully responsible for the correctness and completeness of the Submission including the contents of the Executive Summary, all supporting documents and data.
- c. the nominee represents and warrants that all information supplied in connection with each Submission is truthful and accurate and it has full rights to provide TUCSS with all the rights provided herein.
- d. valid consent, permission, authorisation and/or licence from any party including third party as may be required for the Submission and the Nomination and disclosure, evaluation and/or use of all documents, materials, data and contents of the Submission including the Materials as contemplated under these Conditions of Award) shall have been obtained prior to or at the time of the Submission.

- e. recipient of the Award shall share information relating to its winning project with the tunnelling industry and consent to the showcasing of its winning project at such forum and in such form as may be required by TUCSS such as presentations, seminars, exhibitions and/or company visits at no costs to TUCSS.
- f. TUCSS will not be required to return any Materials or any part thereof submitted for and/or in connection with the Nomination and TUCSS shall have the right to use, disclose, disseminate, reproduce, retain and/or process such Materials submitted in any way it deems fit for the Purposes, without the need to seek any further consent from or payment of fees or royalties or whatsoever charges or compensation to the nominee or any other party regardless of the results of the Award.
- g. TUCSS's decision in respect of the winner of the Award is final. There shall be no claim whatsoever against TUCSS arising from its decision.
- h.
